



Analysing and updating of the scenarios for the evolution of the energy system

Formulating proposals for the design of new policy measures and the re-design of the existing in the case of deviations

Providing guidance to the involved institutions

Coordinating and organizing the public consultations at national and regional level



Duties

- Coordinating the monitoring and the implementation of the proposals by the Interministerial Committee within the framework of the NECP
- Developing a governance framework in order to monitor, control and supervise the implementation of the policy measures and the achievement of the specified targets
- Elaborating the relevant progress reports according to the Regulation 2018/1999 / EU, as well as the internal progress reports
- Providing recommendations to the Interministerial Committee on the redesign of existing and the design of new policy measures

Composition


- Ministry of Environment and Energy (three nominated members)
- Regulatory Authority of Energy (one nominated member)
- Center for Renewable Energy Sources and Saving (two nominated members)
- External experts (three nominated members)

- □ The Minister of Environment and Energy is responsible for defining the responsibilities and the operational framework.
- Development of a holistic mechanism for monitoring the implemented policy measures including the definition of each vital elements (such as required data sources, procedures, indicators, IT systems) and the required resources.
- □ The General Directors for Energy and Environmental Policy can participate into the meetings.
- Establishment of ad-hoc technical working groups to monitor the implementation of the NECP.
- Invitation of representatives from other bodies, organizations, associations or unions, as well as experts in financial, technical, scientific and other issues.
